CALL TO ORDER: 7:01 PM by Board Chair, Mike Fagan.

MARCH TOWN BOARD MINUTES: MOTION by Schwenn/Fagan to approve the minutes of the March 19 meeting as presented. MOTION carried 2-0.

PUBLIC INPUT - NON AGENDA ITEMS:

Citizen, who was unable to attend March 19 TB meeting voiced concerns about the town not having a burn ordinance. Fagan asked if she would be interested in forming a committee to research a burn ordinance and bring their ideas to a TB meeting. He offered the use of the Town Hall to hold the meetings. She said yes. Springdale's MHFD represented offered to help out. She will contact the Town if/when she needs Town Hall and has information to present to the TB.

MT VERNON CEMETERY UPDATE – Town Support Harland Erfurth gave a financial update and reported a need for additional funds, probable just this one year, to maintain access. Fagan pointed out that the Town budget for 2018 was approved last December.
