## **KURTZ – GAMMETER** TWO-LOT CSM/PROCEDURAL MATTER TO CLEAN UP PROPERTY LINE FOR LOTS 1 AND 2 ALONG GAMMETER ROAD:

<u>Background</u>: Lot 1 and 2 CSM 14551 recorded in Vol. 100 of Certified Survey Maps 232-233 is revised to establish the westerly property line of Lot 1 and 2 on Gammeter Road and the southerly lot line of Lot 1 and the northerly lot line of Lot 2 to each other by eliminating an unnecessary half-moon area of road right-of-way along the eastern edge of Gammeter Road. The right-of-way of Gammeter Road is now 66' wide its entire length. The required paperwork for the discontinuance of this unnecessary half-moon area of road right-of-way shall be recorded by the Town at the Dane County Register of Deeds once this revised CSM is approved by the Town Board.

These parcels of real property contain no further land divisions for development according to the current Town land use plan and ordinances. 2.
