- 3. Discussion of current year/budget. Rosenbaum explained the 3 meetings and their purposes.

Major Ongoing Annual Town Expenses (2023)

- Fire department dues \$280,000
- Contracted road maintenance \$220,000
- Staff and board salaries \$152,000
- Debt service Fire department building \$77,000

Increasing Costs

- Fire department dues increasing from \$280,415 in 2023 to \$353,106 (+26%).
- Road maintenance costs asphalt costs continue to be high. Costs per ton in 2019 vs 2023:
 - Overlay costs increased from \$59 to \$77
 - Wedging costs increased from \$77 to \$82
- Spent \$211,143 in 2023 on outside contractors (exceeded budget by \$30K). Budgeting \$220,000 in 2024 for outside contractors.
- Staff salaries Budgeting for 5% increases for 2023

Non-Recurring Expenses in 2024 Budget

- \$100,000 for repair or replacement of Town Hall roof and certain trusses and supports. Leaks in roof have caused rot in some trusses over the years.
- \$34,300 for reassessment of all properties in the town. Rough valuations compared to market values (Residential 64%, Commercial 58%, Agricultural 70%, MFL land, Forest land, Unimproved land 75%)
- **Saving for Capital Needs** We've been saving for capital needs for the past four years and now have \$66,000 set aside to go towards the future purchase of a truck, tractor etc. We've added another \$30,000 to this budget.
- 4. Presentation of the 2024 Town of Springdale Budget

Proposed Budget

Levy - 2023 levy was \$715,265. 2024 Levy with 1.34% increase (net new construction) = \$724,866. Mill Rate - Slight Mill Rate decrease from 1.9875 per thousand in 2023 to 1.9863 per thousand in 2024. Impact on \$300,000 property value: -\$.36.

Overview of Other Funds

• ARPA (American Rescue Plan Act) and Cardinal Hickory Powerline payments. Springdale received \$105,000 in ARPA funds in both 2021 and 2022. Funds can be

used for "government services." Decisions on how to spend remaining funds must be made by 12/31/24 and spent by 12/31/26. We intend to spend \$112,500 of ARPA money on roads in 2024.

• "Environmental Impact Fees" distributed to towns in the path of the Cardinal-Hickory Creek powerline. Springdale received \$310,000 in June 2022.

Springdale Debt – only Town debt is the mortgage on Mt. Horeb Fire Department and Public Safety Building. Total loan amount is \$7,130,000. Paying \$77,121.59 /year through 2029 (mortgage + reserve fund payments). Paying \$70,110.54 /year through 2059 (once reserve fund is full).

Reminder that Town taxes are a small percentage (approx. 10-12%) of the total property tax bill, depending on school district!
