**RESOLUTION NO. 2023-2-1**

A RESOLUTION TO AMEND THE TOWN FEE SCHEDULE, INCREASING FEES FOR DOG LICENSING AND REDUCING THE FEE FOR TOWN RECORDS


**WHEREAS**, on December 20, 2022, the Springdale Town Board approved Ordinance 2022-12-3 (Title 7, Chapter 1) to update the outdated fees for the licensing of dogs, as well as to create a multiple dog (kennel) license and fee; and

**WHEREAS**, also on December 20, 2022, the Springdale Town Board amended the Town public records policy, approving a reduction in copying fees to more accurately reflect Town copying costs as per Wis. Stat. 19.35(3)(a).

**NOW, THEREFORE**, the Town Board of the Town of Springdale, Dane County, Wisconsin, does hereby resolve to amend the Town of Springdale fee schedule to reflect the above-mentioned changes to the Town fee schedule. These changes shall be effective upon adoption and after this Resolution has been duly noticed and published pursuant to the applicable Wisconsin Statutes.
