

# MINUTES

## SPRINGDALE TOWN BOARD

WEDNESDAY, MARCH 29, 2023 AT 6:00 P.M.

1. **Call to order and certification of compliance with open meetings law.** Rosenbaum call to order at 6:00 PM via Zoom; Supervisors Schwenn and Hefty present at Town Hall along with Patrolman Dahlk and Admin/Clerk Arthur. No bidders present at Town Hall. Admin/Clerk Arthur confirms that meeting was posted according to the open meeting law on 3/23 (springdalewi.gov) and 3/24 at Town Hall. Mt. Horeb Mail notified 3/23. Confirmation also that the bids were published separately by the Mt. Horeb mail as Class 2 notices – LRIP/Town Hall Rd on 3/16 & 3/23, and culverts/hot mix wedging also on 3/16 & 3/23 (affidavits on last page of minutes).
2. **Approval of the agenda** by unanimous consent. No changes.
3. **Correction of the 2/28 TB meeting minutes to reflect correct BOR meet to adjourn date.** Arthur realized that the 2/28 meeting minutes, as approved, are incorrect as they read that the BOR Meet-To-Adjourn meeting is set for Tuesday, 4/25 at 6:50 PM “before the Town Board Meeting.” The intent was that the meeting be Monday, 4/24, before the PC meeting.  
**MOTION** (Schwenn/Hefty) to change the minutes to say 4/24 at 6:50 PM for the BOR meet to adjourn meeting. No further discussion. 3 ayes, 0 nays, motion carried.
4. **2023 bid opening for Springdale road projects.** 2 sealed bids were received at Town Hall for culverts, and 3 for each LRIP and overlay/wedging.  
**Culverts** – Town Hall Rd. and Zahler Rd.
  - Finks - \$5,950
  - **S&E - \$5,400 total** (\$2,200 for Zahler and \$3,200 for Town Hall Rd.)**MOTION** (Schwenn/Hefty) to accept S&E’s low bid for culvert replacement on Zahler and Town Hall Roads. Clerk will notify S&E of the bid acceptance and require proof of insurance. No further discussion. 3 ayes, 0 nays, motion carried.  
**LRIP Overlay**
  - Tri-County Paving – 925 tons, \$80.13/ton, \$74,120.25
  - **Payne + Dolan – 925 tons, \$77/ton, additional \$2,000 for milling and butt joints, \$73,225**
  - Scott Construction – 925 tons, \$87.55/ton, \$80,983.75**MOTION** (Hefty/Schwenn) to accept Payne + Dolan’s bid of 925 tons for \$77/ton for a total of \$71,225; plus mill and butt joints for a total of \$73,225. Discussion that Payne + Dolan are doing Hwy 92 currently, so they will probably complete these projects around the same time. Part of Town acceptance of bid is completion by 8/15. No further discussion. 3 ayes, 0 nays, motion carried.  
**Hot Mix Wedging** (1,500 tons for Coray Ln., Lunde Ln., Messerschmidt, Spring Rose Rd., Town Hall Rd., and Witte Rd.)
  - Scott Construction - \$96.50/ton; \$144,740
  - Tri County Paving - \$98.80/ton; \$148,200
  - Payne + Dolan - \$82/ton; \$123,000**MOTION** (Hefty/Schwenn) to accept Payne + Dolan’s bid for hot mix wedging at \$82/ton for 1,500 tons for a total of \$123,000. Dahlk is happy with their work, hauling a shorter distance so the mix is hotter when it gets here. No further discussion. 3 ayes, 0 nays, motion carried.
5. **Adjournment**  
**MOTION** (Schwenn/Hefty) to adjourn at 6:27 PM. No further discussion. 3 ayes, 0 nays.

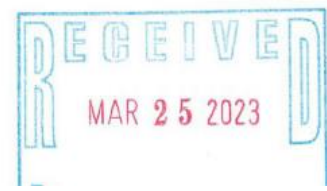
