3. L. Hellenbrand/ Lands on J and South of Dairy Ridge Road/Lot line Adjustment and concept plan revision/ Sec 14.

NOTE: The initial request for consideration of a Lot Line Adjustment of part of the Hellenbrand lands west of J to the Yahara Quarry was not able to be entertained because the two lands being joined would not have had the same owners – it would simply be a land division. It was determined that a lot line adjustment did not fit with the landowner's goals and the request was withdrawn. NO ACTION TAKEN.



MOTION (Jester/ Sullivan) to recommend to the TB a revision of the concept plan for the Hellenbrand lands to move 2 of the development areas from the lands west of J to the lands east of J in the woods between the road and the ravine. This will require Dane County to grant an access point for a shared driveway to the area of the woods on the east of County J. This revision moves density units off farmland and better meets the goals of the land use plan. 6 ayes, 0 nays.

original farmhouse on this land as of the plan adoption date.

We discussed that like other places in the town there is the issue of access off County Road PD. We do not know where or if the county would grant access. Currently there are two farm access roads off PD to the north fields. County access may affect density unit allocations. PC Chair Jester will connect Mackler to Dane County Highway.

We decided to set a site date once the corn is harvested to have access to better site lines. Mackler will contact the town to schedule.
