3. J. Barker and L. Rupe/ 9091 RIDGEVIEW RD/ 10x20 Accessory building / Sec 8.

MOTION (Jester/Hanson): To recommend to the TB approval of a 10x20 accessory building for personal storage at 9091 Ridgeview. 6- ayes, 0-nays. MOTION CARRIED.

Discussion: This accessory building is a freestanding 200 sq ft shed to the east and lower than the original accessory building. NO water or electricity. It was purchased from a relative's estate and is already in place as the timing of the permit/ meeting cadence didn't quite line up to have it done before taking delivery. Neighbors were notified.

4. A. and N. Carrico/ 8177 COUNTY HIGHWAY G/ Revert to original Concept plan/ Notice non completion of prior Lot Line Adjustment, Rezone and CSM /Sec 25.

NOTICE FOR MINUTES: The Carrico's have decided not to pursue the lot line adjustment and the resulting rezone and new CSM. Dane County issued a notice that #12078 was withdrawn. So, town actions taken to approve a lot line adjustment (June 2024) and subsequent CSM and REZONE (July 2024) are also null.



Discussion: The Carrico's reconsidered their request for a revision to the concept plan and a reconfiguration of the lots and they wish to leave things in their original state due to an interested buyer in one of the original lots. The town had previously supported the original concept plan for this month and the lots and zoning are already in place this action is merely to make town records consistent with the fact that the applicant changed their minds before completing the action with the county. In the discussion we noted that the correction to the LOT 3 CSM and zoning (a CSM is required for lots over 35 in the Town of Springdale) will be forthcoming in the next month or so.
