Crack Filling Service, Corp., 4033 Barlow Rd., Cross Plains, WI 53528 – accepted reasonable bid: \$7,150.00 Fahrner Asphalt Sealers, LLC, 316 Raemisch Rd., Waunakee, WI 53597- unaccepted bid: \$6,985.00

MOTION (Fagan) Rosenbaum seconded to accept the bid from Crack Filling Service, Corp., the bid that is \$165.00 higher than the other bid because the Town has had a positive, substantiated working relationship with Crack Filling Service, Corp. versus the other company with which the Town of Springdale is having difficulty with over work done in 2020. The problem with the 2020 work done by Fahrner Asphalt Sealers, LLC, has been documented with poor adhesion to the surface/peeling (on Springdale Center Rd. and Bakken Rd.) The chip sealing failed. Pea gravel did not adhere to the roadway. The excessive pea gravel had to be swept to the roadsides by individual property owners and the Town for road safety. The Town Patrolman Dahlk met at the

site of one problem area with a Fahrner company representative. To date, the company has failed to remedy the situation. Motion to approve carried 3 ayes, 0 nayes 6:55 p.m.
