**Attendance:** Town Supervisor I, John Rosenbaum, Board Supervisor II, R Schwenn, and Clerk, S Duerst Severson. Patrolman, D Dahlk, attended via conference call. Town Chair, M Fagan, was unable to attend. A quorum of the Town Board is in attendance.

Called to Order Board Supervisor II, R Schwenn

**Confirm posting** Clerk: Yes, 3 customary places by 2:30 PM today.

**Agenda:** The purpose of this session is to discuss and possibly take action regarding road maintenance on Messerschmidt Drive due to a culvert collapse. Discussion: Patrolman Dahlk reported a culvert collapsed on Messerschmidt. He has placed warning cones to alert traffic. The location has a double culvert, each is 24" x 45'. One has failed and the other needs to be replaced. Cost effective to just do both now; should be less than \$1300 for a pair of corrugated plastic N24 culverts. Town pays cost of culverts, contractor installs.

Dahlk called Fink's for estimate to dig up and replace both culvers and do asphalt patch after it settles; they quoted a cost of approximately \$3000. Devin called diggers hot line, they can take up to three business days; which is fine because Finks cannot get here until next week. Tentative repair will take place on June 25 and will close the road for one day. Patrolman believes the total cost will be less than \$4,500. Because the total cost is expected to be less than \$5000, the Town does not have to follow bidding rules, which will expedite getting the road repair done.
