On June 16, 2020, the Springdale Town Board approved *Resolution No. 2020-5-1*, amending the Town's administrative fee schedule.

## RESOLUTION NO. 2020-5-1

### TOWN OF SPRINGDALE DANE COUNTY, WISCONSIN

#### A RESOLUTION TO ADOPT FEES PURSUANT TO THE TOWN OF SPRINGDALE CODE OF ORDINANCES TITLE 9, CHAPTER 3.16 ADMINISTRATIVE FEES

**WHEREAS**, Title 9, Chapter 3.7 of the Springdale Code provides for the establishment of reasonable fees for the administration of land division and subdividing; and

**WHEREAS**, the Town Board has completed a review of the Town fee schedule to clarify items and bring parity with Dane County Zoning practices.


**NOW, THEREFORE**, based on the above, the Town Board of the Town of Springdale, Dane County, Wisconsin, does hereby resolve to amend the Town of Springdale fee schedule as follows:

1. **CSM, Preliminary.** Add a fee of \$25 for each additional lot to the existing fee of \$200 for a Preliminary Certified Survey Map.
2. **CSM, Re-application.** Add a fee of \$25 for each additional lot and change the existing \$100 fee to only apply to CSM re-applications that require *no* changes. Add a \$200 fee to those CSM re-applications that *do* require changes.
3. **CSM, lots of more than 35-80 acres.** Add a new fee of \$100, plus a town engineer review fee to CSMs for lots of more than 35-80 acres.
4. **Plat; Plat Preliminary Review; and Plat Submission of Final.** Add "*Option 1*" to the existing "*Option 3*" for all. No plat fee changes.
5. **Rezoning per Application.** Add a fee of \$25 for each additional lot to the existing \$225 fee for rezoning. Change "rezoning per parcel" to "rezoning per application."

The above mentioned changes to the fee schedule shall be effective upon adoption and after this Resolution has been duly noticed and published pursuant to the applicable Wisconsin Statutes.
